GENERAL REQUIREMENTS FOR ISSUANCE OF A TRAVEL DOCUMENT

1. Accomplish application form. Parents may accomplish the form for minors.
2. Submit two (2) passport pictures, 2" x 2", front view, colored or black and white with plain white background taken within the last six (6) months. Photo must show applicant in proper attire without eyeglasses. **(T-SHIRTS AND OTHER CASUAL ATTIRE ARE NOT ALLOWED).**
3. Submit copy of Birth Certificate.

If lost or not available, submit the following:

- a) Certificate of Non-Availability of Birth Record from the Local Civil Registrar
 - b) Baptismal Certificate/Voter's ID or any public document indicating birth particulars and Philippine citizenship
 - c) Joint Affidavit by two disinterested persons
 - d) Other supporting documents issued in the Philippines which will establish applicant's identity as Filipino citizen, e.g. marriage certificate, school records, professional ID, NBI clearance, Seaman's book, Land Titles, Income Tax Returns, Voter's Affidavit from COMELEC
 - e) Copy of Philippine passport
4. Submit copy of alien registration card (green/pink card for U.S. permanent residents)
 5. Submit proof of actual residence e.g. Photocopy of Driver's license, state ID, employment ID, or utility bills, etc.
 6. For minors, submit a notarized Affidavit of Support and Consent from both parents.
 7. Submit an **Affidavit of Loss/Explanation**, duly notarized stating the circumstances surrounding the lost of the passport. *Indicate the passport number, date and place of issue.*
Attach Police Report, if passport was stolen.
 8. For **female applicant** married in the **Philippines** and who will use her married name for the first time, submit original/certified true copy and photocopy of marriage certificate
 9. For **female applicant** married in the **U.S.** who needs amendment of her last name, a **Report of Marriage** shall be filed in triplicate, (download the Report of Marriage form and list of requirements)
 10. **IF APPLICANT IS UNABLE TO APPEAR IN PERSON, FORM HAS TO BE NOTARIZED**
 11. **CONSULAR FEE:**

NO PERSONAL CHECKS ARE ACCEPTED

*** Applicant has to send the corresponding fee in **money order or bank draft payable to the Philippine Consulate General.**

If the applicant wishes the Consulate to mail back the travel document, a self-addressed stamped priority certified/express mail envelope or prepaid FEDEX/UPS or Express Mail is required.
